Instructions on Obtaining a Letter of Non-Filing

To obtain a "Verification of Non-filing Letter" you can go to www.IRS.gov and click on "Get My Tax Record" and then click on "Get Transcript ONLINE", or you can call 1-800-908-9946. If the IRS has no record of any 2018 tax return being filed under your Social Security Number, then instead of a tax transcript, you will receive a letter confirming your non-filing.

A Letter of Non-Filing must accompany this worksheet if this is the option that you select. A written statement, submission of W2's, or simply checking the non-filing option will not be enough to clear verification
